# OSCaR Updates - May 2020

 As we adjust our lives around COVID-19 many of us have had to adjust how we do business and do our work in Oregon as well as across the world. As trainings and conferences are put on hold for at least this year many wonder what will happen in the future. And while we do not know all the answers we must continue to be safe and be flexible.

I know that many of the CTR's attend these trainings and conferences depend on CE's earned for their CTR credential. I reached out to Mary Maul to ask and see what NCRA was planning to offer anything via online. NCRA is looking at their options but there is nothing definitive to date.

I just want to remind everyone that if you need CE's there are a few remote options.

- If you haven't signed up already to participate in the NAACCR webinars series OSCaR subscribes to and you want to be added to the list for the NAACCR webinar series please send Linda Shan an email with your contact info and your facility. Three (3) CE's per webinar are available for these if you take and pass the quiz.

### **Question:**

Histology--Corpus uteri: Is 8020/3 used for a predominantly dedifferentiated carcinoma with focal well-differentiated endometrioid adenocarcinoma diagnosed in 2018? See Discussion.

# **Discussion:**

After a little research, it appears as though Endometrial Dedifferentiated carcinoma is a relatively new term and is set to be included in ICD-O-3.2:

If you look at the link on that page for All Additions, Changes, and Revisions to the ICD-O-3, 1st Revision for ICDO-3.2, there is 8020/3 Dedifferentiated carcinoma. Currently, 8020/3 is Carcinoma, undifferentiated, NOS. For 2018 diagnosis, would you use 8020/3 for a predominantly dedifferentiated carcinoma with focal well-differentiated endometrioid adenocarcinoma as stated in the pathology: Uterus, bilateral ovaries and fallopian tubes; supracervical hysterectomy/BSO: Predominantly dedifferentiated carcinoma with focal well-differentiated endometrioid adenocarcinoma in the endometrium, FIGO grade 1 Portion of omentum, omental/anterior abdominal wall/ round ligament/uterine/small bowel mesenteric tumor nodules all involved by dedifferentiated carcinoma predominantly Histological Grade: Endometrioid carcinoma, FIGO grade 1.

# Answer:

Assign code 8380/3 for endometrioid carcinoma, NOS as this is listed as the histological type in the synoptic report.

# QA on cases- OSCaR Database:

Upon review of a large batch of cases (2,300) **Tumor Size** was often coded different among those cases that merged with another facility for the same cancer, same patient. Also noticed some discrepancy even within a single abstract. Below are some snips from the STORE manual.

**Priority of imaging/radiographic techniques**: Information on size from imaging/radiographic techniques can be used to code size when there is no more specific size information from a pathology or operative report, but it should be taken as low priority, over a physical exam.

**Tumor size discrepancies among imaging and radiographic reports**: If there is a difference in reported tumor size among imaging and radiographic techniques, unless the physician specifies which imaging is most accurate, record the largest size in the record, regardless of which imaging technique reports it.

**Multifocal/multicentric tumors**: If the tumor is multi-focal or if multiple tumors are reported as a single primary, code the size of the largest invasive tumor or if all the tumors are in situ, code the size of the largest in situ tumor.

### **Palliative Care-Coding Tips:**

#### Date of First Course Treatment/Palliative Care:

When a patient receives palliative care for pain management only with no other cancer-directed treatment, Date of First Course of Treatment, NAACCR Data Item #1270, would be the date in which a patient decides on palliative care for pain management only, as recommended by the physician. "No therapy" is a treatment option that occurs if the patient refuses treatment, the family or guardian refuses treatment, the patient dies before treatment starts, or the physician recommends no treatment be given, or the physician recommends palliative care for pain management only.

# **Coding Spanish/Hispanic Origin:**

#### Spanish Origin is independent of race. A patient can be ANY race and have Spanish Origin coded to 1 - 8.

- Patients with a known birth country and their last name or maiden name is NOT on the Spanish Surname list (and no further information regarding ethnicity in the medical record), code to 0.
- Patients with dual last names where only one of the last names appears on the Spanish Surname list (and no other information in the medical record regarding ethnicity), code to 7.
- Patients born in Mexico (if their last name or maiden name is on the Spanish Surname list), code to 1.
- Portuguese, Brazilian and Filipino patients are not presumed to be Spanish or non-Spanish. If their last name or maiden name appears on the Spanish Surname list, code to 7.

If the last name or maiden name does NOT appear on the Spanish Surname list, code to 0.

# Michele Henson Memorial Scholarship Fund – The Story Behind It

In October 2001, we lost a great registrar to lung cancer. OCRA set up a Memorial Fund for her and in 2002 re-named the scholarship to the Michele Henson Memorial Scholarship Fund.

Michele was born November 8, 1953 in Los Angeles, CA and married Tom Henson on November 16, 1981. Michele wanted a higher education for herself and she wanted to make a difference in the world.

Michele started working in the registry in 1996 in Douglas Community Hospital in Roseburg, Oregon and later transferred to Mercy Medical Center. She took the CTR exam in March in 1999 in Beaverton along with Donna, a fellow registrar, from Portland. Donna's notification letter was first to come, leaving Michele on pins and needles for the next two days, until her letter came. She was very excited to receive that passing letter. Receiving her credentials was very important to Michele. She was delighted to receive a balloon bouquet and a stuffed animal attached with congratulations on passing her exam, on behalf of OCRA. Michele noted how blessed she felt when people would stop by to ask "What's the occasion?"

Michele was also recognized at the NCRA banquet for new registrars held in New Mexico, in May 2000. Michele was a hard worker and truly loved her job. She always gave 150% of herself. Anyone who met Michele knew she was a special person. She has so much love and faith and was a friend to all. She had a passion for garage sales, junk shops and the like. She loved her home and the fact that she could eventually work from home. Working from home was her ultimate goal.

She was able to start her own contracting business, but it wasn't long before she became ill. Michele was a strong person, and she put up a fight to the end.

One day she asked her husband what would be her legacy after she died? His answer was the kids, but there was more. Michele had hung a poster on the wall with a saying "100 years from now, I will have been a Cancer Registrar" and the sign still hangs. That is what drove Michele to the higher education she wanted, as she wanted to make a difference. Tom would find Michele in bed sick with her cancer but still working on cases that she wanted to get done. Tom stated that there are many things that he could write about Michele but one thing that really is the most evident about her life and to all who knew her was her drive to be the best that she could be.
