Social Security Numbers (SS#)

One of the common errors we often find on consolidated cases and/or multiple sequence cases is the SS# being misreported and/or entered incorrectly. We just want to remind everyone to please be diligent in entering the correct SS# into the abstract and/or to check against the medical record when needed.

Required Site-Specific Factors for 2016+ cases

Site specific factors (SSFs) that impact directly-assigned AJCC-TNM 7th Edition Stage Group (e.g. PSA for prostate) or that are prognostic factors of interest, remain important to collect for cancer surveillance. Please be sure to include these in your abstracts. The Collaborative Stage SSF data items will continue to be used for this purpose.

OSCaR RA Update:

One of the essential aspects of the work conducted by the OSCaR program is providing data for cancer research projects aimed at improving the quality of cancer treatment and survivorship. OSCaR uses the data submitted by various cancer reporters in Oregon to identify patients diagnosed with cancer and to provide those patients with the opportunity to participate in studies that contribute to the cancer knowledge base. Patients participating in these studies are typically invited to complete surveys or to participate directly in interventions that are designed to improve the quality of life for cancer survivors.

In the past, OSCaR has coordinated patient recruitments so that the initial patient contact came from OSCaR, however, these recruitments require significant staff time and resources. As part of efforts to improve the efficiency of registry operations, OSCaR has changed its approach to coordinating these patient recruitment projects. Now, research staff will be required to handle the initial patient contacts for these recruitment studies, as is permitted under section 333-010-055 of the Oregon Administrative Rules. As with any research study, proposals for patient recruitment studies are reviewed and approved by both the OSCaR Advisory Committee and the Oregon Public Health Institutional Review Board before any patient information is released, to ensure that the researchers comply with patient confidentiality and data security guidelines.

This change in OSCaR's research procedures will reduce the amount of OSCaR staff time required for these patient recruitment projects, which will increase the potential for OSCaR staff to work on additional research studies and further contribute to the scientific knowledge base for cancer. We want you to know that your work in compiling and reporting cancer data to OSCAR is essential to the efforts to reduce the burden of cancer, both locally and nationally. In short, your data is used to improve the prevention, early detection, and treatment of cancer, and OSCaR is continuously looking for ways to expand and improve the way we put your data to work.
